Re: Notice of Intention to Designate Two Properties within Norfolk County under the Ontario Heritage Act

Please be advised that the Council of The Corporation of Norfolk County intends to designate the following two buildings located within Norfolk County under the Ontario Heritage Act. Both buildings are located on one property being 200 Talbot Road, Delhi, Ontario.

Notice of Intention to Designate Quance Saw Mill and

Delhi Tobacco Museum and Heritage Centre Tobacco Kiln

TAKE NOTICE THAT, the Council of The Corporation of Norfolk County intends to pass two By-Laws pursuant to the provisions of the Ontario Heritage Act, to designate the Quance Saw Mill located at the Delhi Quance Park (circa 1916) and the Delhi Tobacco Museum and Heritage Centre Tobacco Kiln, both located on property described as Part Lot 2, Part Lot 3, Part Lot 5 and Part Lot 6, Block 6, Plan 189, RP 37R460 Part 1, RP 37R284 Part 1, municipally known as 200 Talbot Road, Delhi, within Norfolk County, as being of cultural heritage value or interest.

The following paragraphs outline the reasons each building warrants designation as historical, cultural and architectural importance to the community of Delhi and Norfolk County and protection under the Ontario Heritage Act.

Quance Saw Mill

The Quance Saw Mill building located at the Delhi Quance Park is all that remains of an extensive industrial complex on Big Creek in the community of Delhi. It possesses strong heritage importance in the building itself and its contents and pays homage to a historically important industrial area which contributed to the development of the Village of Delhi, the Long Point Region and ultimately Norfolk County. The following building features are specifically noted for their architectural significance:

- the exterior design and profile of the building, particularly the cement foundation in its unpainted condition
- · the design and placement of all openings in their present condition
- all interior wood frame construction including beams, trusses and flooring
- the exterior shiplap beneath the exterior finish
- all lumbering equipment and tools remaining in the building excluding the steam boiler

Delhi Tobacco Museum and Heritage Centre Tobacco Kiln

This iconic Tobacco Kiln, adjacent to the Delhi Tobacco Museum and Heritage Centre, is a visual reminder and landmark representing the influential period in the history and heritage of Norfolk County's flue-cured tobacco industry. The following building features are specifically noted for their architectural significance:

- the simple design and profile of the square building with its heritage colour treatment
- · the design and placement of all openings including the furnace door
- · the interior wood frame construction including all the beams
- the exterior shiplap

Further information respecting the proposed designations is available at the Clerk's office, Norfolk County Administration Building, 50 Colborne Street South, Simcoe.

Any person who objects to the proposed designations may serve on the Clerk of Norfolk County, not later than the 26th day of May, 2017, a notice of objection setting out the reason for objection and all relevant facts.
