BY-LAW NUMBER 1980-70

A by-law to designate certain property as property of historic and architectural value and interest (85 Navy Street)

THE COUNCIL ENACTS AS FOLLOWS:

& /Marie

- 1. The property known municipally as 85 Navy Street is hereby designated as a property of historic and architectural value and interest pursuant to The Ontario Heritage Act, 1974.
- 2. The property designated by this by-law is the property described in Schedule "A" to this by-law.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Oakville, in the Regional Municipality of Halton (formerly the County of Halton) in the Province of Ontario and being composed of Lot D and the Southwesterly Thirty-four feet Four inches (34'4") from the front to rear of Lot E in Block 9, as the said lots appear in the map of the said Town of Oakville, drawn by R. W. Kerr, Esq., Deputy Provincial Surveyor, dated the first day of August, 1836, and recorded in the Registry Office of the said Regional Municipality of Halton on the 12th day of January, 1850.

REASON FOR PROPOSED DESIGNATION

On the architectural grounds that it is a well preserved example of an Ontario Regency Style Cottage having many of its fine original architectural features in fine condition. Historically the house was built Circa 1848 for Lt. Colonel George K. Chisholm who later became the Town's Mayor. In later years the house was owned by Richard S. Wood, founder of the "Oakville Oil Refinery". In 1903, the house was sold to Captain Maurice Fitzgerald, Captain of one of the last sailing schooners on the Great Lakes.
