THE CORPORATION OF THE TOWN OF OAKVILLE

BY-LAW NUMBER 2002-054

A by-law to amend By-law 1995-44, a by-law to designate the property formerly known as 502 Dundas Street West (now 2441 Neyagawa Blvd) as a property of historical, architectural and contextual value and interest.

WHEREAS the property municipally known as 502 Dundas Street West, and more particularly described as Part of Lot 20, Concession 1 South of Dundas Street, Town of Oakville, Regional Municipality of Halton, designated as Part 1 on Plan 20R-11668 (the "property") was designated as a property of historical, architectural and contextual value and interest pursuant to the *Ontario Heritage Act*, R.S.O. 1990, c. O.18 by By-law 1995-44;

AND WHEREAS the house on the property has been moved to a new location within the property and has been assigned the new municipal address of 2441 Neyagawa Boulevard;

AND WHEREAS the Owner of the property has requested that Council amend By-law 1995-44 so that it ceases to apply to Parts 1 and 2 on Plan 20R-14531;

THE COUNCIL ENACTS AS FOLLOWS:

- 1. By-law 1995-44 is hereby amended by deleting the words "municipally known as 502 Dundas Street West" in paragraph 1 of the By-law and replacing them with "formerly municipally known as 502 Dundas Street West, and now municipally known as 2441 Neyagawa Boulevard".
- 2. By-law 1995-44 is hereby further amended by adding the following paragraph at the end of Schedule "A" to By-law 1995-44.

"In 2000, the barn was removed and the house at 502 Dundas Street was moved from its original location to the south west corner of the property. The house has been assigned a new municipal address of 2441 Neyagawa Boulevard."

- 3. By-law 1995-44 is amended by deleting Schedule "B" and replacing it with Schedule "B" attached to this by-law.
- 4. The property described as Part of Lot 20, Concession 1, South of Dundas Street, Town of Oakville, Regional Municipality of Halton designated as Parts 1 and 2 on Plan 20R-14531, Part 1 on Plan 20R-14541 and Parts 1 to 5, inclusive, on Plan 20R-13730, is hereby released from the application of By-law 1995-44.
