RE: MERRICK THOMAS HOUSE

PURSUANT TO Subsection (6) of Section 29 of The Ontario Heritage Act, 1974;

TAKE NOTICE THAT Oakville Town Council, by by-law, on February 6th, 1978, did designate a certain property as a property of historic and architectural value and interest. The by-law is detailed below, together with an explanation of the reason for the designation:

THE CORPORATION OF THE TOWN OF OAKVILLE
BY-LAW NUMBER 1978-6

A by-law to designate certain property as property of historic and architectural value and interest (Merrick Thomas House).

THE COUNCIL ENACTS AS FOLLOWS:

1. The property commonly known and referred to as the Merrick Thomas House is hereby designated as a property of historic and architectural value and interest pursuant to The Ontario Heritage Act, 1974.
2. The property designated by this by-law is the property described in Schedule "A" to this by-law.
3. The designation affects only as much of the lot as is covered by the Merrick Thomas House.

SCHEDULE "A" to By-law Number 1978-6

ALL AND SINGULAR that certain parcel or tract of land situate, lying and being in the Town of Oakville, in the Regional Municipality of Halton and being composed of Lot B, Block 77 according to the original plan for the Town of Oakville (now commonly referred to as Plan 1) registered in the Land Registry Office for the Land Registry Division of Halton.

REASON FOR DESIGNATION

The Merrick Thomas House is a well preserved example of a typical small dwelling succeeding the Log House. Historically, it was built in 1829 by Merrick Thomas, who came to Oakville as General Superintendent for the founder of the Town, W. Chisholm. Previously located on the north side of Lakeshore Road West, the Merrick Thomas House was sold by the Department of National Defense to the Oakville Historical Society and was then relocated to Lakeside Park.


