NOTICE OF INTENTION TO REPEAL A DESIGNATING BY-LAW

TAKE NOTICE that the Council of the Corporation of the City of Pembroke intends to repeal By-law 95-02 which designates the following property:

PEMBROKE PUMP HOUSE  
Concession I, Part Lot 19  
9 Riverside Drive

Reasons for Proposed De-designation

The designation of the Pembroke Pump House was proposed for architectural and historical reasons.

The reasons for Council's intention to repeal the designating by-law is the cost of repairing the building to a safe level and the cost of restoring the building to its original condition.

Any person may before the 21st day of October, 1996, send by registered mail or deliver to the Chief Administrative Officer, notice of his or her objection to the intention to repeal Designating By-law 95-02 together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection has been received, Council will refer the matter to the Conservation Review Board for a hearing and report.
