IN THE MATTER OF The Ontario Heritage Act 1974, Statutes of Ontario, 1974, Chapter 122, as amended;

AND IN THE MATTER OF the lands and premises known municipally as 103-105 Rideau Street, in the City of Ottawa, in the Province of Ontario.

NOTICE OF DESIGNATING BY-LAW

TAKE NOTICE that the Council of The Corporation of the City of Ottawa on the 1st day of October , 1980, enacted By-law Number 327-80 designating the lands and buildings known municipally as 103-105 Rideau Street, as a property of architectural value or interest under The Ontario Heritage Act, 1974, Statutes of Ontario 1974, Chapter 122, as amended.

STATEMENT OF REASONS FOR THE DESIGNATION:

The property at 103-105 Rideau Street is recommended for designation as being of architectural interest. In its overall exterior appearance above the ground floor, the building is a good example of Mid-Victorian vernacular commercial style. Erected circa 1869, this three storey, flat-roofed brick structure features repeated segmental-arched windows and a bracketed cornice. The building is one of six which form a consistent turn of the century commercial streetscape along the north side of Rideau Street between Freiman and William Streets; as such the purpose of the designation is to preserve the Rideau Street facade.

A by-law of The Corporation of the City of Ottawa to designate 103 - 105 Rideau Street, to be of architectural value or interest;

WHEREAS The Ontario Heritage Act, 1974, Statutes of Ontario, 1974, Chapter 122, as amended, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Ottawa has caused to be served upon the owner of the lands and premises known as 103 - 105 Rideau Street, more particularly described in Schedule "A" hereto, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in Le Droit newspaper having a general circulation in the City of Ottawa, once a week for three consecutive weeks, namely on 2nd, 9th and 16th days of August, 1980;

AND WHEREAS the reasons for the designation are set out as Schedule "B" hereto;

AND WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the City of Ottawa;

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:-

- 1. There is designated as being of architectural value or interest the real property, more particularly described in Schedule "A" hereto, known as 103-105 Rideau Street.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.

- The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the property described in Schedule "A", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having a general circulation in the City of Ottawa.
- 4. The Schedules attached hereto and marked Schedule "A" and Schedule "B" form part of this by-law and all notations, references and other information contained therein shall be as much a part of this by-law as if all the matters and information set forth by the said schedules were all fully described herein.

HERITAGE DESIGNATION, 103-105 RIDEAU STREET SCHEDULE A

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of Ottawa, Regional Municipality of Ottawa-Carleton and Province of Ontario and BEING COMPOSED OF part of Lot Letter "G" on the north side of Rideau Street according to a plan filed in the Land Registry Office for the Land Registry Division of Ottawa-Carleton Number 5 as Registered Plan Number 42482, more particularly described as follows:-

COMMENCING on the north side of Rideau Street aforesaid where a post has been planted at the south-easterly angle of said Lot Letter "G" in the boundary line between said Lot Letter "G" and Lot Letter "H" on Rideau Street aforesaid;

THENCE westerly along Rideau Street a distance of 21 feet 6 inches to where a post has been planted;

THENCE northerly parallel with the boundary line between said Lot Letter "G" and Lot Letter "H" 199 feet and 8 2/3rd inches more or less to George Street to where a post has been planted;

THENCE easterly along George Street 21 feet 6 inches to said Lot Letter "H";

THENCE southerly along the boundary line between said Lot Letter "G" and Lot Letter "H" 199 feet 8 2/3rd inches more or less to the place of beginning.
