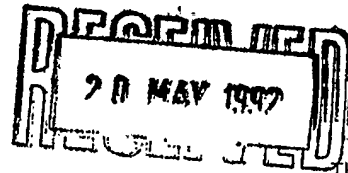

AND WHEREAS notice of intention to designate certain properties within the Municipality was served on the owners of the properties and the Ontario Heritage Foundation, on March 26, 1992, and was published in the Perth Courier on April 1st, April 8th, and April 15th, 1992.

AND WHEREAS no objections were received against the designation of the said properties as a result of the aforementioned notices:

NOW THEREFORE the Municipal Council of the Corporation of the Town of Perth ENACTS AS FOLLOWS:

1. By-Law No. 2978 - For St. Andrew's Presbyterian Church
1 Drummond Street West
2. By-Law No. 2979 - For the St. Andrew's Presbyterian Church
Apartment and Office Building
25 - 27 Foster Street
3. By-Law No. 2980 - For Code's Mill at 53 Herriott Street

1 Drummond Street West, Perth

REASON FOR DESIGNATION:

This stone church was built in 1927 and is of the Gothic Revival Style with fine stained glass windows.


This by-law shall come into force and take effect on the passing thereof.
