



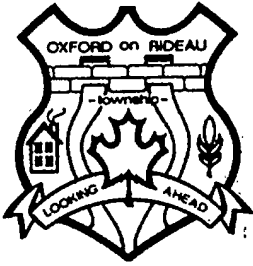

THE CORPORATION OF THE TOWNSHIP OF OXFORD-ON-RIDEAU

BY-LAW NO. 54-94

Being a By-law to designate the property known as
Maplewood Hall S.S. No. 8
as being of architectural and historical interest

WHEREAS the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, authorizes Municipal Councils to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value and interest.

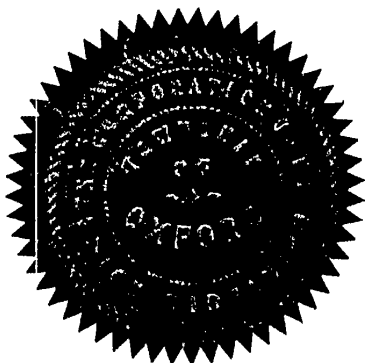
AND WHEREAS the Council of the Corporation of the Township of Oxford-On-Rideau has served notice of its intentions to designate the property known as Maplewood Hall in Oxford Mills situated on Part Lot 16, Concession 5, 92 Maplewood Avenue, Village of Oxford Mills, as being of architectural and historical value and interest, on the owners of the property, the Ontario Heritage Foundation and has caused such Notice to be published in a newspaper having general circulation in the Municipality for three consecutive weeks;


AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Township;


THEREFORE Council enacts as follows:


1. The lands and premises known as Maplewood Hall in Oxford Mills situated on Part Lot 16, Concession 5, 92 Maplewood Avenue, Village of Oxford Mills are hereby designated as being of architectural and historical interest and value.
2. The Township's solicitor is hereby authorized to cause a copy of this by-law to be registered against the subject property in the proper land registry.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation, the owners of the subject lands and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the Municipality.
