Dear Ms. Axford:

The Council of the Town of New Tecumseth, at its meeting on January 29, 2007, has confirmed its intention to designate the Alliston Monuments Works, 51 Victoria Street East, Alliston, pursuant to Section 29 of the *Ontario Heritage Act, 2005.* In accordance with Section 29 s. (3), notice of this intention to designate is required to be served on the owner of the property.

The reason for the designation of the building is to preserve its heritage value under Ontario Regulation 9/06 as being rare, unique, representative and an early example of a style, type, expression, material and construction method. The building is a fine example of a small commercial building in almost original condition and has housed the longest continuous business in New Tecumseth.

A person who objects to a proposed designation shall, within thirty days after January 31, 2007, serve on the Clerk of the municipality a notice of objection setting out the reason for the objection and all relevant facts. R.S.O. 1990, c.O.18, s.29 (5); 1996, c. 4, s. 55 (2).

IN THE MATTER OF THE ONTARIO HERITAGE ACT; 2005 AND THE ALLISTON MONUMENT WORKS, 51 VICTORIA STREET EAST, ALLISTON

Take notice that the Town of New Tecumseth intends to designate the Alliston Monument Works, 51 Victoria. Street East, Alliston, under Section 29 of the Ontario Heritage Act, 2005.

The said property is being designated to preserve its heritage value under Ontario Regulation 9/06 as being rare, unique, representative and an early example of a style, type, expression, material and construction method.

The said building was constructed in 1901 and the interior and exterior of the building have remained relatively unchanged. The plain, solid brick one-storey building has a typical storefront facade with a parapet terminating in a flat roofline. The window sash and door case have many elements that are either original or have been carefully replicated. Much of the interior trim is original. The building is a fine example of a small commercial building in almost original condition and has housed the longest continuous business in New Tecumseth.

Notice of any objection to the proposed designation may be served on the Clerk, 10 Wellington Street East, Alliston, Ontario L9R 1A1 within 30 days of January 31, 2007.

The notice of objection must set out the reason(s) and all relevant facts.
