THE CORPORATION OF THE TOWN OF MONO

BYLAW NUMBER 2002-34

BEING A BYLAW TO REPEAL BYLAW NUMBER 2002-18 AND TO DESIGNATE THE "DESLAURIERS PROPERTY", THE EAST HALF OF LOT 23, CONCESSION 7 EAST OF HURONTARIO STREET, TOWN OF MONO AS BEING OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST UNDER THE ONTARIO HERITAGE ACT.

WHEREAS Section 29 of the Ontario Heritage Act authorizes the Council of a municipality to enact bylaws to designate real property, including all buildings, structures and parts thereof in the municipality to be of historic or architectural value or interest; and

WHEREAS the Council of the Town of Mono has caused notice of its intention to designate the property described herein (the East Half of Lot 23, Concession 7 EHS, Town of Mono) to be served on the owner thereof and on the Ontario Heritage Foundation and to be published in a newspaper having general circulation in the Town of Mono; and


WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Corporation of the Town of Mono;

THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MONO ENACTS AS FOLLOWS:


1. The property described as the "DesLauriers property" in the East Half of Lot 23, Concession 7 East of Hurontario Street, Town of Mono, entered in the municipal assessment roll as 003-18200, is hereby designated as being of architectural value or interest.
2. The Town's solicitor is hereby authorized to cause a copy of this bylaw to be registered upon the title to the property described above in the Land Registry Office, and Patricia L. Sproule Ward of Mullin Thwaites Ward LLP may execute by electronic means, on behalf of the Town, any documents requiring registration that relate to the registration of the bylaw and any other documents required to give effect to this bylaw.
3. The Clerk is hereby authorized to cause a copy of this bylaw to be served on the owner of the property described in Part 1 and on the Ontario Heritage Foundation and to cause notice of this bylaw to be published in a newspaper having general circulation in the Town of Mono.
4. Bylaw Number 2002-18 is hereby repealed.
