BY-LAW NUMBER 13203

A BY-LAW TO DESIGNATE A CERTAIN PROPERTY/LOCOMOTIVE WITHIN THE CITY OF BELLEVILLE TO BE OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST (LOCOMOTIVE #2534 - WEST ZWICK'S PARK)

WHEREAS Section 29 of the Ontario Heritage Act, 1980 provides that where the council of a municipality has given notice of its intention to designate a property/locomotive to be of historic or architectural value or interest and where objections to said notice of designation are duly received and duly processed through the Conservation Review Board, the council shall pass a by-law designating the property/locomotive to be of historic or architectural value or interest;

AND WHEREAS all statutory requirements for giving notice of council's intention to pass a by-law designating the property/locomotive herein described to be of historic or architectural value have been complied with;

AND WHEREAS no objections to said notice of designation were received;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:

1. THAT the property/locomotive located at West Zwick's Park, which parcel of land is more particularly described in SCHEDULE "A" attached hereto, be and the same is designated as a property/locomotive of historic or architectural value or interest, for the reasons stated in SCHEDULE "B" attached hereto as provided for in the Ontario Heritage Act, 1980.

2. THAT nothing in this By-Law shall be construed to designate any of the lands described in SCHEDULE "A" attached hereto to be of historic or architectural interest, as provided in the Ontario Heritage Act, 1980.

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.

Read a first time this 2nd day of December, 1991.

REASONS FOR THE PROPOSED DESIGNATION

LOCOMOTIVE #2534 - WEST ZWICK'S PARK

HISTORY

As of December 31, 1960, all remaining steam engines were written off the C.N.R.'s records and within a year, most had been dismantled. A few units were sold or donated to various municipalities, associations or to private individuals for museums or historical preservation. Almost all Consolidation 280s have been sent to the scrapper's torch. Only 6 remain - Kamloops, B.C.; Englehart, Ont.; Belleville, Ont.; Delson, Quebec (at the CRHA Museum); Haliburton, Ont.; and Transcona, Manitoba. One other 280 Consolidation was converted to an 080 and remains in storage in London, Ontario. Only a total of 70 C.N.R. steam locomotives are preserved in the world, some are in the U.S.A. Of the survivors, Belleville's is the 4th oldest. A 260 line was built in 1900, and is now in the National Museum of Science and Technology. A 460 was built in 1901 and is now in Edmonton, Alberta. The oldest remaining Consolidation was built in 1905, only one year before Locomotive 2534. Only three other 280 Consolidation locomotives, besides Belleville's were built in that year.

It is appropriate that a fixture such as Locomotive 2534 remain on display as a continuous reminder of Belleville's heritage as a railroad town. At one time, Belleville's landscape sported yard engines, shops, wooden coal chutes, water towers, boiler rooms, bunkhouses, the world's largest roundhouse and turn table. For generations (since the Grand Trunk was completed between Toronto and Montreal in 1856) a common sight was the puff of smoke and a shot of steam. At one time, one railroader estimated that 60 to 70% of Belleville's workers were employed by the railroad. Generations of Belleville workers did the tough, heavy, dirty and menial work that was necessary to keep Canada's economy going. Little remains of the railroad aspect of our heritage except Locomotive 2534.
