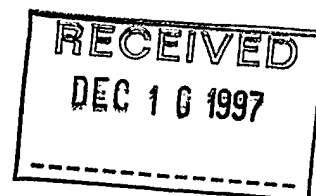

CORPORATION OF THE TOWNSHIP OF RADCLIFFE

BY-LAW # 97-21

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN  
MUNICIPALLY AS PART LOT 6 & 7, CONCESSION  
V, RADCLIFFE TOWNSHIP

WHEREAS Section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Radcliffe has caused to be served on the owners of the lands and premises known as Part Lot 6 & 7, Concession V, Radcliffe Township and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality for one time only, and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Township of Radcliffe enacts as follows:

- 1) There is designated as being of architectural and/or historical value or interest the real property known as St. Paul's Anglican Rectory at Part Lot 6 & 7, Concession V, Radcliffe Township.
- 2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper for one time only having general circulation in the municipality.

READ a first and second time this 17th day of November, 1997.

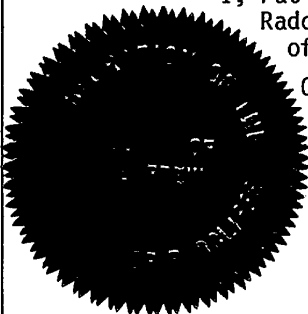
