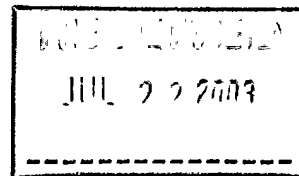

## PUBLIC NOTICE

### Intention to Repeal Historical Designation for the Woodford Hotel

Further to Section 31 of the Ontario Heritage Act, R.S.O. 1990, c.O.18, Notice is hereby given that the Council of the Municipality of Meaford has received a request to repeal By-law 1989-17, of the former Township of Sydenham, which designated the Woodford Hotel at Part Lots 3 and 4 in Concession One, NCR, formerly in the Township of Sydenham, now in the Municipality of Meaford, as being of Architectural and Historical Value or Interest.
