**PUBLIC NOTICE
INTENT TO REPEAL DESIGNATION**

Pursuant to Section 31 of the Ontario Heritage Act, R.S.O., 1989, Chapter 337 as amended, the Corporation of Township of Goulbourn has received positively the recommendation of its Local Architectural Conservation Advisory Committee to repeal the designation on the following property as Building of Historic and Architectural value:
