
I would now confirm that By-Law Number 13489 was registered as Instrument No. 494124 on October 29, 1993.

## THE CORPORATION OF THE CITY OF BELLEVILLE

## BY-LAW NUMBER 13489

A BY-LAW TO RESCIND BY-LAW NUMBER 12502 BEING A BY-LAW TO DESIGNATE A BUILDING WITHIN THE CITY OF BELLEVILLE TO BE OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST (MUNICIPAL NO. 96 ST. CHARLES STREET)

WHEREAS By-Law Number 12502 was duly passed by the Council of The Corporation of the City of Belleville on the 6th day of September, 1988;

AND WHEREAS it is now deemed to be necessary and expedient that By-Law Number 12502 be rescinded.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:

 THAT By-Law Number 12502 being a by-law to designate a building within the City of Belleville to be of historic or architectural value or interest (Municipal No. 96 St. Charles Street), be and the same is hereby rescinded. (The parcel of land is more particularly described in SCHEDULE "A" attached hereto.)

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.

Read a first time this-4th-day of October,-1993.

Read a second time this 4th day of October, 1993.

Read a third time and finally passed this 4th day of October, 1993.
