BY-LAW NUMBER 14108

A BY-LAW TO RESCIND BY-LAW NUMBER 13203 BEING A BY-LAW TO DESIGNATE A CERTAIN PROPERTY/LOCOMOTIVE WITHIN THE CITY OF BELLEVILLE TO BE OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST (LOCOMOTIVE #2534 - WEST ZWICK'S PARK)

WHEREAS By-Law Number 13203 was duly passed by the Council of The Corporation of the City of Belleville on the 2nd day of December, 1991;

AND WHEREAS it is now deemed to be necessary and expedient that By-Law Number 13203 be rescinded;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:



THAT By-Law Number 13203 being a By-Law to designate a certain property/locomotive within the City of Belleville to be of historic or architectural value or interest (Locomotive #2534 - West Zwick's Park), and all other By-Laws or parts thereof inconsistent herewith be and the same are hereby rescinded. (The parcel of land is more particularly described in SCHEDULE "A" attached hereto.)

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.

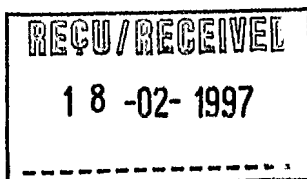
