DY-LAW LUMBER . 193-78

A by-law of The Corporation of the City of Ottawa to designate 193-195 Comberland Street to be of historic or exchitectural value or interest;

the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interact;

ALD UNICHEAS the Council of The Corporation of the City of Ottawa has caused to be served upon the owner of the lends and premises known as 193-195 Cumberland Street, more particularly described in Schedule "A" horseto, and upon the Ontario Heritago Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in The Journal newspaper having a general circulation in the City of Ottawa, once a week for three consecutive weeks, manely on April 18, April 25 and May 2, 1978;

AND WHEREAS the reasons for the designation are set out as Schedulo "h" hereto;

AED EMERIAS so notice of objection to the said proposed designation has been served upon the Clerk of the municipality:

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:-

- 1. There is designated as being of historic or stohitectural value or interest the real property, more particularly described in Schedule "A" hereto, known as 193-199 Cumberland Street.
- 2. The City Colicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is bereby authorized to cause a copy of this by-law to be served upon the evener of the property described in Schedule "A", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published

in a newspaper having a general circulation in the City of Ottawn.

references and other information contained therein shall be
as much a part of this by-law as if all the matters and
information set forth by the said schedules were all fully
described herein.

ALL AND SINGULAR that cortain parcel or tract of land and premises situate lying and being in the City of Ottowa, in the Regional Hunicipality of Ottowa-Carleton and Province of Ontario, DIRIC CONFORD OF:-

NOTICE OF BY-LAW

TAKE NOTICE that the Council of The Corporation of the City of Ottawa on the 21st day of June 1978, enacted By-law Number 193-78 designating the lands and buildings known municipally as 193-195 Cumberland Street as a property of architectural and historical value or interest under The Ontario Heritage Act 1974, Statutes of Ontario, 1974, Chapter 122.

STATEMENT OF REASONS FOR THE DESIGNATION:

"The two and one-half storey stone building at 193-195 Cumberland Street is recommended for designation as being of architectural and historical value. Erected circa 1862, this sturdy stone structure is a simple vernacular building, though in the classical tradition. It is of particular interest as an example of a combined business and residence, having been used historically as a grocery."
