THE CORPORATION OF THE TOWNSHIP OF RIDEAU

BY-LAW NO.31/83

Being a by-law to designate  
the property known as "Tupper  
House-Thunderwood Farm" as  
being a property of architectural  
and historical value and interest.

WHEREAS the Ontario Heritage Act, R.S.O. 1980,  
Chapter 337, authorizes municipal councils to enact by-laws to  
designate real property, including all buildings and structures  
thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of The Corporation of the  
Township of Rideau has served notice of its intention to  
designate the property known as "Tupper House-Thunderwood Farm"  
situate on Part of the West Half of Lot 23, Concession 1 of  
the former Township of North Gower, now in the Township of  
Rideau, as being a property of architectural and historical  
value and interest, on the owner of the property, the Ontario  
Heritage Foundation, and has caused such notice to be published  
in newspapers having general circulation in the municipality  
for three consecutive weeks;


AND WHEREAS no notice of objection to the proposed  
designation has been served on the Clerk of the Township;


THEREFORE Council Enacts As Follows:

1. The lands and premises known as "Tupper House-Thunderwood  
Farm" situate on Part of the West Half of Lot 23,  
Concession 1 of the former Township of North Gower, now  
in the Township of Rideau are hereby designated as being  
of architectural and historical value and interest.


2. The Township's solicitor is hereby authorized to cause a copy of this by-law to be registered against the aforesaid property in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation, the owner of the subject lands, and to cause notice of the passing of this by-law to be published in newspapers having general circulation in the municipality.



## REASONS FOR DESIGNATION

BY-LAW NO. 31/83

### Property Designated

By-law No. 31/83 is a by-law designating the lands and premises known as "Tupper House-Thunderwood Farm" situate on Part of the West Half of Lot 23, Concession 1 of the former Township of North Gower, now in the Township of Rideau, as being a property of architectural and historical value and interest.

### Reasons For Designation

The Tupper House of Thunderwood Farm, built in the 1850's by John O'Callaghan, is a fine example of the one and a half storey, gable roofed, front gabled, stone farmhouses built throughout the Rideau River Valley in the 19th century.

Take notice that the Council of the Corporation of the Township of Rideau has passed By-law No. 31/83, being a by-law to designate the lands and premises known as "Tupper House - Thunderwood Farm" situate on Part of the West Half of Lot 23, Concession 1 of the former Township of North Gower, now in the Township of Rideau, as a property of architectural and historical value and interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.
