HERITAGE DESIGNATION

Ottawa City Council, on June 7th, 1995, passed By-law No. 110-95, which repeals part of By-law number 221-90 designating **589 RIDEAU STREET** (Wallis House) as a heritage property for its historical and architectural value under the Ontario Heritage Act.

The effect of this By-law will be to remove certain vacant lands adjacent to the historic Wallis House from the heritage designation By-law.

BY-LAW NUMBER 110-95

A by-law of The Corporation of the City of Ottawa repealing By-law Number 221-90 as to certain lands.

WHEREAS By-law Number 221-90 was enacted by the Council of The Corporation of the City of Ottawa on September 5, 1990 to designate as being of historic and architectural value or interest the real property municipally known as 589 Rideau Street and legally described in Schedule "A" attached to By-law Number 221-90 (such real property now being designated as Parts 1, 2, 3, 4 and 5 on Reference Plan 4R-11083);

AND WHEREAS the the real property legally described as Parts of Lots 43, 44, 45, 46 and 47 and Part of Lot 42, North Rideau Street and Part of Tormey Street (as closed), Registered Plan 43586, City of Ottawa, Regional Municipality of Ottawa-Carleton designated as Parts 1, 2, 4 and 5 on Plan 4R-11083, being a portion of the lands described in Schedule "A" attached to By-law Number 221-90, provided and the Council of The Composition of the City of Ottawa at the Council of The Composition of the City of Ottawa at the Council of The Composition of the City of Ottawa at the Council of The Composition of the City of Ottawa at the Council of The Composition of the City of Ottawa at the Council of The Composition of the City of Ottawa at the City of Ottawa. are to be developed and the Council of The Corporation of the City of Ottawa at its meeting of May 17, 1995 authorized the repeal of By-law Number 221-90 only with respect to the said Parts 1, 2, 4 and 5 on Plan 4R-11083.

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:

- 1. By-law Number 221-90 is hereby repealed only as it affects the lands legally described as Parts of Lots 43, 44, 45, 46 and 47 and Part of Lot 42, North Rideau Street and Part of Tormey Street (as closed), Registered Plan 43586, City of Ottawa, Regional Municipality of Ottawa-Carleton designated as Parts 1, 2, 4 and 5 on Plan 4R-11083; and
- By-law Number 221-90 remains in full force and effect with respect to Parts of Lots 43, 44, 45, 46 and 47 and Part of Lot 42, North Rideau Street, Registered Plan 43586, City of Ottawa, Regional Municipality of Ottawa-Carleton designated as Part 3 on Plan 4R-11083.
