BY-LAW NUMBER . 78-83 . . .

A by-law of The Corporation of the City of Ottawa to
designate 125 MacKay Street to be
of historic and architectural value or interest;

WHEREAS the Ontario Heritage Act, R.S.O. 1980, c. 337,
authorizes the Council of a municipality to enact by-laws to
designate real property, including all the buildings and structures
thereon, to be of historic and architectural value or interest;

AND WHEREAS the Council of The Corporation of the City
of Ottawa has caused to be served upon the owners of the lands and
premises known as 125 MacKay Street more
particularly described in Schedule "A" hereto, and upon the Ontario
Heritage Foundation, notice of intention to so designate the afore-
said real property and has caused such notice of intention to be
published in the Le Droit newspaper having a general
circulation in the City of Ottawa, once a week for three consecutive
weeks, namely on the 27th day of November, and the 4th and 11th
days of December, 1982.

AND WHEREAS the reasons for the designation are set out
as Schedule "B" hereto;

AND WHEREAS no notice of objection to the said proposed
designation has been served upon the Clerk of the City of Ottawa;

THEREFORE the Council of The Corporation of the City of
Ottawa enacts as follows:

1. There is designated as being of historic and architectural
value or interest the real property, more particularly described in
Schedule "A" hereto, known as 125 MacKay Street.
2. The City Solicitor is hereby authorized to cause a copy
of this by-law to be registered against the property described in
Schedule "A" hereto in the proper Land Registry Office.

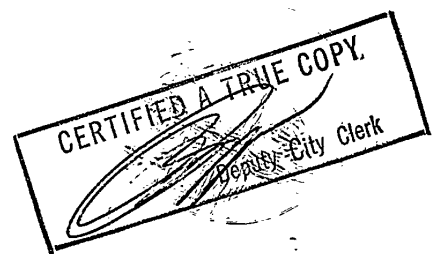
3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owners of the property described in Schedule "A", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having a general circulation in the City of Ottawa.

4. The schedules attached hereto and marked Schedule "A" and Schedule "B" form part of this by-law and all notations, references and other information contained therein shall be as much a part of this by-law as if all the matters and information set forth by the said schedules were all fully described herein.

SCHEDULE A

HERITAGE DESIGNATION, 125 MacKay Street

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of Ottawa, Regional Municipality of Ottawa-Carleton, and Province of Ontario, BEING COMPOSED OF Lot Number 12 in Block 11 on the south side of MacKay Street, according to a plan registered in the Land Registry Office for the Registry Division of Ottawa-Carleton Number 5 as number 17. The above described lands are those lands in registered instrument number CR161027.

SCHEDULE "B"

STATEMENT OF REASON

St. Bartholomew's Church at 125 MacKay Street is recommended for designation as being of architectural and historical value. Built in 1868 to a design attributed to Thomas Scott, the Church has been the parish of many New Edinburgh residents as well as numerous Governors General.

This rectangular Church, constructed of stone with a steeply pitched roof and a low profile, is easily associated with the early village of New Edinburgh. The Church is further enhanced by its gabled dormers, pointed arched windows and the stone buttresses.

The above does not make reference to the interior or any additions to the west.
