





THE CORPORATION OF THE VILLAGE OF BAYFIELD BY-LAW 516-91

Being a by-law to designate property of Architectural and/or Historical significance as an Heritage property under the terms of Part 1V of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

AND WHEREAS The Ontario Heritage Act, R.S.O. 1980 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures as set out in "Schedule A" to this by-law to be of architectural and/or historical significance;

AND WHEREAS the Council of the Corporation of the Village of Bayfield has cause to serve upon the owner of lands and premises as set out in "Schedule A" of this by-law and upon the Ontario Heritage Foundation, Notice of Intention to Designate this real property and has caused such Notice of Intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; AND WHEREAS no Notice of Objection to the said proposed designation has been served upon the Clerk-Treasurer of the municipality;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE VILLAGE OF BAYFIELD ENACTS AS FOLLOWS:

- All real property as described in "Schedule A" of this by-law is designated as being of architectural and/or historical significance.
- 2. The Clerk-Treasurer of the Corporation is hereby authorized to cause a copy of this by-law to be registered on the title of this property as described in "Schedule A" in the Registry Office, County of Huron, Goderich, Ontario.
- 3. The Clerk-Treasurer is hereby authorized to cause a copy of this by-law to be served on the owner of the said property described in "Schedule A" and upon the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the Village of Bayfield.
- 4. This by-law shall come into effect on its passing.

Read a first, second, third time and finally passed this 6th day of August 1991.

THE ONTARIO HERITAGE ACT R.S.O. 1980, C 337, 529

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Corporation of the Village of Bayfield intends to designate the property known as the Hunter Residence at the municipal address of Plan 147, lot 194, as a building of architectural and/or historical significance, under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

Building: , residence

Address: 1 Anne Street

Date: Circa 1850

SIGNIFICANCE: The Corporation intends to designate the property described above and specifically the house with addition built circa 1850, the barn, the chicken coop and the wire fence with pussy cat gate latches. It is intended that the house, outbuildings and the fence be preserved in its present form including paint colour ie; white with red trim.

The house is deemed to be of social and architectural interest having been a harness shop, wagon and woodworking shops. It is one of the few frame two storey buildings basically unaltered since 1850.

ANY PERSON may within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Village of Bayfield notice of his or her objection and all relevant facts. If such Notice of Objection is received, the Council of the Corporation of the Village of Bayfield shall refer the matter to the Conservation Review Board for a hearing.
