NOTICE IS HEREBY GIVEN that the Council of The Corporation of the Town of Simcoe intends to designate as a place of architectural and/or historic value or interest the following property, under Section IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18:

Lynnwood Park is a 4 acre site of stately trees and grassy knolls centrally located in the Town of Simcoe. Tradition claims it was under a mighty oak in this park that Lieutenant-Governor Simcoe granted Aaron Culver a mill site privilege which set in motion the course of development for the Town. Later, as part of the grounds of Lynnwood Estate, this northern section was fenced and allowed to remain a natural preserve for deer. In 1903, Lynnwood Park was given as a gift to the Town with conditions that would preserve its natural and historical identity. The preservation of this parkland has allowed subsequent park development to form a greenspace corridor throughout the Town, linking it to the extensive trails of the Simcoe Walkway, the Brook Conservation Area and the Lynn Valley Trail.

The detailed reasons for designation of this property are available from the Office of the Clerk, 50 Colborne Street South, Simcoe, Ontario, N3Y 4N5, during normal office hours (8:30 a.m. to 4:30 p.m., Monday to Friday).

NOTICE of objection to the designation of the said property shall be served on the Clerk, setting out the reasons for objection and all relevant facts, within thirty days after the date of this publication of Notice of Intention. The date of publication and the last day for filing an objection of the intended designation are listed above.
