# By-Law 2014-134

Being a By-Law to Designate the Robb/Pond-Manorome "The Blue Elephant Craft Brew House" Establishment, located at 96 Norfolk Street South, Simcoe, more particularly described as Part of Lot 6, Block 103, Plan 182, Norfolk County, as being of Cultural Heritage Value and Interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O., Chapter O.18, authorizes the Council of a municipality to enact by-laws to designate real property within the municipality, including all buildings and structures thereof, to be of cultural heritage value and interest;

AND WHEREAS the Council of The Corporation of Norfolk County deems it desirable to designate the Robb/Pond-Manorome "The Blue Elephant Craft Brew House" Establishment, located at 96 Norfolk Street South, Simcoe, more particularly described as Part of Lot 6, Block 103, Plan 182, Norfolk County, as being of cultural heritage value and interest;

AND WHEREAS Notice of Intention to Designate the Robb/Pond-Manorome "The Blue Elephant Craft Brew House" Establishment, was served on the owners of the property and on the Ontario Heritage Trust and such notice was published in the Simcoe Times Reformer and the Lakeshore Shopper, newspapers having general circulation in the municipality;

**AND WHEREAS** the reasons for designation are set out in Schedule 'B' attached to and forming part of this By-Law;

**AND WHEREAS** no notice of objection to the proposed designation has been served on the Clerk of the municipality.

**NOW THEREFORE** the Council of The Corporation of Norfolk County hereby enacts as follows:

1. That the real property known as the Robb/Pond-Manorome "The Blue Elephant Craft Brew House" Establishment, located at 96 Norfolk Street South, Simcoe, more particularly described as Part Lot 6, Block 103, Plan 182, Norfolk County, is hereby designated as being of cultural heritage value and interest.

- That the Clerk is hereby authorized and instructed to register a copy of this By-Law against the property described in Schedule 'A', attached hereto, in the Registry Office of the Land Registry Division of Norfolk.
- 3. That the Clerk/or his/her designate, is hereby authorized to amend the parcel designation noted in this By-Law, if necessary, upon registration of this By-Law.
- 4. That the Clerk is hereby authorized to cause a copy of this By-Law to be served on the owners of the aforesaid property and on the Ontario Heritage Trust and to cause notice of this By-law to be published in the Simcoe Times Reformer and in the Lakeshore Shopper
- 5. That the effective date of this By-Law shall be the date of final passage thereof.

## Reasons for Designation Under the Ontario Heritage Act, R.S.O. 1990, Chapter O.18

### Robb/Pond Manorome "The Blue Elephant Craft Brew House" Establishment

#### **Description of Property:**

The Robb/Pond Manorome "The Blue Elephant Craft Brew House" Establishment is a Victorian home located at 96 Norfolk Street South, Simcoe, Ontario, more particularly described as Part Lot 6, Block 103, Plan 182, Norfolk County.

### **Cultural Heritage Value or Interest:**

The early history of the property begins with a Crown Grant in 1799. There appears to have been speculative buying and selling during the early 1800's with changes in ownership over the years. A most remarkable resident includes a Victorian ghost of a young lady in Victorian dress and other memorable residents include Gladys Bartholomew and sister Greta. Gladys was associated with the Royal Conservatory of Music and taught piano and theory.

Popularly known as the "Blue Elephant" restaurant, this house, circa 1885, is Norfolk's first microbrewery located within one of the large brick Victorian houses which line Norfolk Street. The Robb/Pond Manorome "The Blue Elephant Craft Brew House" Establishment is a fine example of the craftsmanship that went into the Victorian homes in the Town of Simcoe. These stately homes still provide a grand entrance into the town centre from the south. Their exterior details of decorated gables, brackets, chimneys and various styled windows were fully appreciated by carriage and foot traffic.

#### **Description of Heritage Attributes:**

The interior of the house illustrates the grand scale of design that could be achieved in the highceilinged rooms, as seen in the oversized pocket doors and massive French doors of the parlours. The unusual staircase was no doubt considered very modern in its time.

The key attributes of the craftsmanship that went into this Victorian house are reflected in its exterior and interior as follows:

#### Exterior:

East Façade: Original windows and shutters, verandah columns and dentil trim. Projecting pediment of the north corner bay with Palladian window, and roof dormer window, including all the dentil trim, brackets, and decorative wood finishings in both gables.

#### Interior:

First floor wood trim and door and window framing. Pocket doors and French doors. Staircase newels, balustrade, string. Two parlour fireplace mantels, surrounds and hearths. Door and window transoms containing leaded diamond patterned panes. Second floor wood trim and door and window framing.
