
We enclose herewith a copy of a Resolution of North Dumfries Township Council expressing their intent to designate a property within the Municipality together with the Notice of Intent to Designate.



**NOTICE OF INTENTION
TO DESIGNATE**

Take Notice that the Council of the Corporation of the Township of North Dumfries intends to designate the property at the following municipal address as a property of historical and architectural significance under Part IV of the Ontario Heritage R.S.O. 1990, Chapter 0.18.

at
R. R. #1, Ayr, Regional Road #50
Pt Lot 43, Pt Lot 44, Concession 12

The proposed designation recognizes the historical and architectural significance of the subject property.

The one storey fieldstone house, circa 1874, is representative of Scottish cottage architecture. The house which was built by and home to the Perrin family for over one hundred years has an interesting front facade. On either side of the door there are ionic capital columns which are characterized by a capital with large scroll shaped volutes. An open verandah type porch supported by original wooden frame and wooden columns extends the entire length of the front facade.

Designation is intended to cover the front wall, entrance and porch.

Any person may, within thirty days of the first publication of this Notice, send by registered mail or deliver to the Clerk of the Township of North Dumfries, notice of his or her objection to the proposed designation, together with a statement of the reasons of the objection and all relevant facts. If such a notice of objection is received, the Council of the Township of North Dumfries shall refer the matter to the Conservation Review Board for a hearing.
