NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Cobalt intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: 18 Lang Street, Cobalt. Ontario.

Reasons for the Proposed Designation:

The Olympia Candy Store is recommended for designation for architectural and historical reasons. Built in 1910 by Peter Panos, confectioner, it is a typical example of the stores built along Lang Street following the 1909 fire, with its brick construction and elaborate pressed metal cornice, brackets, and finials. It is thus an integral part of the Lang Street cross section of Cobalt's first decade.
