

The current owners of the Maple Hill Building located at 147 Toronto Street, plan on opening a daycare at this location in September.

The scope of work includes:

Exterior work: two fenced off playgrounds with astroturf and asphalt, all trees in this location will have dead branches remove, shutters that have fallen off will be reattached if damage they will be replaced to match existing, and exterior windows that have damage will be replaced with new glazing and/or trim to match existing.
