The Heritage Advisory Committee on February 28, 2006, considered the above captioned matter and recommended the following:

HAC-0008-2006 That the Eden Cemetery located at the southeast corner of Derry Road West and Shelter Bay Road be designated under Part IV of the *Ontario Heritage Act* for reasons of its historical and contextual significance.

This recommendation was approved by General Committee on March 22, 2006 and subsequently adopted by City Council on March 29, 2006.
