	A BY-LAW TO DESIGNATE CERTAIN PROPERTIES IN THE COUNTY OF PRI EDWARD AS BEING OF ARCHITECTURAL, AND/OR HISTORICAL VALUE OR INTEREST.
	WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a Municipality to enact by-laws to designate real property, including all buildings an structures thereon, to be of architectural or historic value of interest;
	WHEREAS The Council of the Corporation of the County of Prince Edward has caused to be served on the owners of the certain la and premises in the County of Prince Edward as more particular described in Schedule "A" of this by-law and upon the Ontario Heritage Foundation, notice of intention to designate the aforesaid real property and has caused such notice of intentio to be published in the same newspaper having general circulati in the Municipality once for each of three consecutive weeks.
	WHEREAS no objection to the proposed designation has been serv on the Clerk of the Municipality;
	THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF PRIN EDWARD enacts as follows:
	 There is designated as being of architectural value or interest the real property known as:
	THE AMELIASBURGH SCHOOL - S.S. #12 in the Township of Ameliasburgh more particularly described as Lot 90, Plan 2RM, Township of Ameliasburgh.
	 THAT a copy of this by-law be registered against the proper described in Schedule "A" hereto attached in the Land Registry Office.
	3) The Clerk is hereby authorized to cause a copy of this by- to be served on the owners of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspape having general circulation in the Municipality once for eac of three weeks.

SCHEDULE "A"

THE AMELIASBURGH SCHOOL - S.S. #12 in the Township of Ameliasburgh more particularly described as Lot 90, Plan 2RM, Township of Ameliasburgh.

The Ameliasburgh School - S.S. #12 at the western entrance to Roblin's Mills has been called the best preserved of Prince Edward County's one-room schools. Built of stone in circa 1848, its age is reflected in the low pitch of the roof and the welldefined eaves return. There are two entrances located on either side of the building. Alongside are three windows, each fitted with twelve-over-eight sash. The building is actually of two sections, the older part to the rear and a later 1890's extension to the front. During restoration, the belfry was returned to the crest of the roof. The former S.S. #12 School is the oldest public building in Ameliasburgh.
