**BY-LAW NO. 452-91**

A By-law to Amend By-law No. 357-90  
(To Designate the Property Known  
Municipally as 10132 Yonge Street of  
Architectural and Historical Value or Interest  
The Lorne Block)

**THE COUNCIL OF THE CORPORATION OF THE TOWN  
OF RICHMOND HILL ENACTS AS FOLLOWS:**

That By-law No. 357-90 is hereby amended by deleting Section 1 and substituting the following therefor:

- \* 1. That the real property located at 10132 Yonge Street, in the Town of Richmond Hill in the Regional Municipality of York, being Lot 27 Registrar's Compiled Plan 12003 and part of Lot 46, Concession 1, (part of lots 23, 36, 37, 38 and 39 Plan 481 (P.S. Gibson's plan unregistered) also known as part of lots 382, 383, 385 and 386 Reuben's Plan Unregistered), (originally the geographic Township of Vaughan)], more particularly described as Part 1, Plan 65R-15499, is hereby designated under Part IV of the Ontario Heritage Act, R.S.O. 1980, as being of architectural and historical value or interest. \*
