BY-LAW NO. 96-13

A By-law to Authorize the Designation of 10185 Yonge Street (Dominion Telegraph Building - formerly known as Sanderson's House and Store) under the Ontario Heritage Act

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.0.18 authorizes the Council of a municipality to enact by-laws to designate real property to be of cultural heritage value or interest;

AND WHEREAS the Council of The Corporation of the Town of Richmond Hill has caused to be served on the owners of the lands and premises known as 10185 Yonge Street, Richmond Hill, and upon the Ontario Heritage Trust, notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to Designate to be published in a newspaper having general circulation in the municipality;

AND WHEREAS the Statement of Cultural Heritage Value or Interest and the Description of Heritage Attributes are set out in Schedule "A" and attached to By-law No. 96-13;

AND WHEREAS no Notice of Objection to the proposed designation has been served on the Town Clerk within the period prescribed by the Ontario Heritage Act.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF RICHMOND HILL ENACTS AS FOLLOWS:

- That the real property located at 10185 Yonge Street, being Lot 1, Plan 7032, Richmond Hill, Regional Municipality of York [PIN NO. 03172-0193 (LT)], are hereby designated under Part IV of the Ontario Heritage Act, R.S.O 1990, Chapter 0.18, as being of cultural heritage value or interest.
- 2. That the Clerk is hereby authorized to cause a copy of the By-law, together with a statement explaining the cultural heritage value or interest of the property and a description of the heritage attributes of the property to be served on the owner of the property and on the Trust, and publish a notice of the By-law in a newspaper having general circulation in the municipality.
- That the Town Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property in the Land Registry Office.
- Schedule "A" attached to By-law No. 96-13 is declared to form a part of this Bylaw.

SCHEDULE "A" TO BY-LAW NO. 96-13

REASONS FOR DESIGNATION Dominion Telegraph Building (also known as Sanderson's House and Store) 10185 Yonge Street

Statement of Cultural Heritage Value or Interest

The Dominion Telegraph Building is a two storey commercial building with retail on the ground floor and apartment/office uses on the second floor. The building is located on the south east corner of Yonge Street and Centre Street East in the village core neighbourhood area of Richmond Hill. The building was constructed in 1877 by the Sanderson family.

The property housed both Richmond Hill's first telegraph office and later Richmond Hill's first telephone exchange. The building is directly historically associated with the location of the Dominion Telegraph Company. The opening of the communities first telegraph exchange in 1871 marked the first time residents had the ability to communicate electronically with other individuals and communities.

Architecturally, the property contains significant design value as a representative example of late-19th century commercial building construction methods. The design value is embodied in the unique and early use of concrete brick construction for a commercial building. The building also exhibits design value through its decorative brick parapet (currently concealed).

The building contextually relates to and supports the character of the village core neighbourhood area through its two storey commercial form which faces directly onto Yonge Street. The building also supports the 19th and early 20th century character of the village core neighbourhood.

Description of Heritage Attributes

Key physical attributes that contribute to the heritage value of 10185 Yonge Street (the Dominion Telegraph Building) based on the 1930 photograph, include the following:

- · The building scale, massing and form;
- Two-storey, commercial design containing ground-floor retail with apartment/office uses on the second floor;
- The building material which is buff coloured concrete brick (currently concealed);
- Three course radiating brick voussoir over second floor windows (currently concealed); and
- Decorative corbelled brick parapet (currently concealed).
