TAKE NOTICE The Corporation of Loyalist Township proposes to designate lands and/or buildings of historical, cultural and/or architectural value as per Part IV of the Ontario Heritage Act, R.S.O. 1990, as amended.

DESCRIPTION

1

The property involved is described as being in Loyalist Township (formerly geographic area of Amherst Island) in the County of Lennox and Addington and the Province of Ontario, and being composed of 1.29 acres of land, between Front Road and Lake Ontario, North Shore Concession, Part of Lot 16.

REASONS FOR DESIGNATION

The Pentland Cemetery, in service from 1831 to 2001, is recommended for designation for historical and cultural reasons detailed below. This cemetery represents a history of original families and forefathers of Amherst Island. The cemetery occupies 1.29 acres of land, between Front Road and Lake Ontario, North Shore Concession, Part of Lot 16 donated by two neighbouring farms one being known as the Towerine farm which was owned by the Pentlands who lived east of the cemetery. Within the lot, the cemetery with headstones and family monuments are dispersed throughout.

The Pentland cemetery was a public burial ground used by all denominations. Farmers residing on each side of the site donated the cemetery lands. In 1831 Samuel Pentleton was the first person buried. The headstone is still decipherable in the cemetery

Notable parts of this cemetery are some finely detailed carved headstones, dating back as early as the 1830's. Unique Irish stone fencing built by John Crowe borders the east and west sides. Famous artist Daniel Fowler whose paintings are displayed in national galleries and abroad was laid to rest in 1894. Original tree growth including spruce and cedar species compliments the cemetery.
