

**NOTICE OF INTENTION TO DESIGNATE**

TAKE NOTICE that the Council of the Corporation of the City of Pickering intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.

1940 Eighth Concession Road  
South Half Lot 16, Concession 8, Pickering

**REASONS FOR DESIGNATION**

The Cleeve Horne House was constructed in 1958 and was the first house in Canada to be built of thin-shell, reinforced concrete and to dispense with bearing wall supports. Cleeve Horne was a distinguished artist noted for his portraits of prominent people, his public sculptures, and his role as an art consultant to Canadian businesses. Jean Horne was an accomplished sculptor whose works of art grace private collections across Canada.

TAKE NOTICE that any person or agency may appeal this Notice by filing with the Clerk of the Corporation of the City of Pickering a statement outlining the reasons for the objection within 30 days of the date of the Notice of Intention to Designate.
