NOTICE OF INTENT TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Sarnia intends to designate the art deco features of the Imperial Oil Centre for the Performing Arts, including the Christina Street facade, the Foyer, the lighting at either side of the stage and the ceiling of the auditorium at the following address, as being of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O, 1990, c.O.18 as amended.

PROPERTY: IMPERIAL OIL CENTRE FOR THE PERFORMING ARTS AT 168
CHRISTINA STREET NORTH, SARNIA

REASONS FOR PROPOSED DESIGNATION

The Imperial Oil Centre for the Performing Arts building (formerly known as the Capital Theatre) was designed and built in 1936. It served as Sarnia's premier movie house from then until the late 1980's. The architectural style is described as "art deco or moderne" and is the only remaining commercial building of this style of architecture in the City. Sarnia Heritage Committee (LACAC) considers specific art deco features such as the front facade, foyer, lighting at either side of the stage and the auditorium ceiling, as being worthy for heritage preservation.

NOTE:

Any person may, within thirty days of the publication of this Notice, send by registered mail or deliver to the Clerk of the City of Sarnia, notice of his or her objection to the proposed designation, together with a statement of reason for the objection and relevant facts. If such Notice of Objection is received, the Council of the Corporation of the City of Sarnia shall refer the matter to the Conservation Review Board for hearing.
