BY-LAW NUMBER 159 OF 2000
OF THE CITY OF SARNIA

"A By-law to designate the City of Sarnia City Gate located at the Christina Street North entrance to Canatara Park, Sarnia, Ontario, as being of Historic or Architectural Value or Interest"

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.O.18 as amended, authorizes the Council of a municipality to enact By-laws to designate real property including all buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS the Municipal Council of the Corporation of the City of Sarnia has caused to be served on the owners of the City of Sarnia City Gates located at the Christina Street North entrance to Canatara Park, Sarnia, Ontario, and upon the Ontario Heritage Foundation, and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once;


AND WHEREAS the reasons for designation are set out in Schedule "B" attached hereto;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;


NOW THEREFORE the Municipal Council of the Corporation of the City of Sarnia enacts as follows;

1. There is designated as being of historic or architectural value or interest the features of the real property more particularly described in Schedule "A" attached hereto, and known as the City of Sarnia City Gate.
2. The City Solicitor is hereby authorized to cause a copy of this By-law to be registered in the proper Land Registry Office against the lands described in Schedule "A" attached hereto, which are lands affected by this By-law.
3. The City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in a newspaper having general circulation in the City of Sarnia.
4. This By-law comes into force and effect upon being finally passed.

SCHEDULE "A"

DESCRIPTION

FIRSTLY:

All of Lot 25, Registered Plan 264(SA), City of Sarnia, County of Lambton, as conveyed to the City of Sarnia in Instrument Number 17942.

SECONDLY:

All and singular that certain parcel or tract of land and premises, situate, lying and being in the Village of Point Edward, in the County of Lambton, containing an area of 4.3 acres more or less, and being composed of all of that part of the 100 foot right-of-way of the Canadian National Railway Company, Point Edward Subdivision, which crosses Lots 67, 68 and 69, Front Concession, formerly in the Township of Sarnia, now in the said Village, the said parcel being bounded on the west by a line drawn parallel to the easterly limit of Sarnia Road (now Front Street) and distant 100 feet easterly therefrom measured at right angles thereto, and bounded on the east by the easterly limit of the said Lot 67, the said parcel being shown coloured green on a print of a plan dated April 24, 1963, attached to Instrument Number 192255.

THIRDLY:

Being part of Lots 67, 68 and 69, Front Concession, Geographic Township of Sarnia now in the City of Sarnia, and partly in the Village of Point Edward, butted and bounded as follows:

On the northerly side by the 100 foot right-of-way of the Canadian National Railway Company (Point Edward Subdivision) crossing said lots; on the westerly side by a line perpendicularly distant 100 feet easterly from and parallel to the easterly limit of Sarnia Road (now Front Street); on the southerly side by the production easterly of the northerly limit of Michigan Street; and on the easterly side by the westerly limit of the road allowance between Lots 66 and 67.

This parcel containing by admeasurement an area of 64.25 acres more or less and shown coloured yellow on a plan attached to Instrument Number 19214 for the City of Sarnia and Instrument Number 3434 for the Village of Point Edward.

SCHEDULE "B"

On July 1st, 1927, the Pro Patria chapter of the IODE (Imperial Order of Daughters of the Empire) ceremoniously presented the City of Sarnia with the gates to the City. The two stone monuments were erected at the corner of London Road and East Street, the then eastern boundary of the City, in honour of Canada's 60th birthday.

Each of the two pillars which were built by Thomas Grace (a local contractor) are made with cut stone, with 4 feet square bases and heights of 10 feet, with lights at the top of each pillar. Financing for the project came from the IODE reserve and a \$10 donation from each of the chapter's members. The stone used in the construction of the pillars was supplied by the Central Canada Stone Company of Point Edward with the McMillan Granite Works of Sarnia completing the granite panels and inscriptions.

For years the gates marked the eastern boundary of the municipality but in 1951, annexation moved the boundary to Murphy Road. The following year (1952) the city fathers elected to move the pillars to the new entrance to Canatara Park where they stand today.

In 1995, the St. Clair Chapter of the IODE celebrated its 80th anniversary and as part of this celebration, the gates were rededicated as the IODE gates.

DECLARATION UNDER SECTION 25 OF THE ACT


