

**CORPORATION OF THE TOWNSHIP OF WILMOT  
BY-LAW NO. 92-89**

**A BY-LAW TO ADOPT THE NEW HAMBURG HERITAGE  
CONSERVATION DISTRICT STUDY AND PLAN**

**WHEREAS** the Official Plan of the Township of Wilmot Planning Area, Section 12.1 contains policies to permit the designation of Heritage Conservation Districts within the Township of Wilmot;

**AND WHEREAS** the Council of the Township of Wilmot under Section 40 (1) of Part V of the Ontario Heritage Act, Chapter O.18, R.S.O., 1990, by by-law No. 91-20 defined the New Hamburg Heritage Conservation District Study Area as an area to be examined for future designation as a Heritage Conservation District;

**AND WHEREAS** the Council of the Township of Wilmot by resolution dated February 25, 1991 undertook the preparation of the New Hamburg Heritage Conservation District Study and Plan;

**AND WHEREAS** a series of public information meetings were held between April 30, 1991 and November 4, 1991;

**AND WHEREAS** a draft Heritage Conservation District Study and Plan dated November 4, 1991 was circulated to all Councillors and various departments for comments, and has been made available for viewing by the public;

**AND WHEREAS** the Local Architectural Conservation Advisory Committee of Council recommends adoption of the Study and Plan;


**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:**

1. That the "New Hamburg Heritage Conservation District Study and Plan" dated November 4, 1991 and revised June 10, 1992 be adopted.

**READ** a first and second time this 13th day of October , 1992.

**READ** a third time and finally passed in open Council this 13th day of October, 1992.
