

CORPORATION OF THE CITY OF TRENTON

BY-LAW NO. 83-340

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN AS
THE POLICE STATION (55 KING STREET) AS BEING
OF BOTH ARCHITECTURAL AND HISTORICAL VALUE.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural and historic value;

AND WHEREAS the Council of the Corporation of the City of Trenton being the owner of the lands and premises known as The Police Station, 55 King Street, has caused notice of intention to designate the aforesaid real property to be served on The Ontario Heritage Foundation and has caused such a notice of intention to be published in The Trentonian, a news paper having general circulation in the municipality, once for each of three consecutive weeks;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF TRENTON ENACTS AS FOLLOWS:

1. The real property including all buildings and structures, being known as The Police Station, 55 King Street, more particularly described in Schedule "A" hereto, is hereby designated as being of architectural and historical value.
2. The Municipal Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this By-Law to be served on The Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

SCHEDULE "A"

The property known as The Police Station, 55 King Street, being Lots 14, 15, 16 and Part of Lot 17, Plan #76, City of Trenton, is recognized as being of architectural and historical value for the following reasons:-

The Police Station (former Town Hall and Market House) is the only one of its kind in the City. It is constructed of limestone in the Classical Revival Style. The classical style is readily apparent in the building proportions, roof form, pediment and fenestration. Many of the original details are still intact including six pane over six pane window sashes, decorative "ear-mould" window surrounds, doorcase to the rear entrance and portions of the cornice and pediment. The building was designed by a prominent architect of the nineteenth century - Kivas Tully. The building was the first Town Hall and included a Market House and lock-up (jail). The building has been used continuously as a police station since construction.

The building has a prominent location in the downtown area of the City.
