CORPORATION OF THE CITY OF TRENTON
BY-LAW NO. 89-1101

A BY-LAW TO REPEAL THE DESIGNATION
OF CERTAIN PARTS OF THE PROPERTY
KNOWN AS THE OLD MARKET BUILDING AND TOWN HALL
(55 KING STREET) FOR THE PURPOSES OF DEMOLITION

WHEREAS the Council of the Corporation of the City of Trenton passed By-Law 83-340 designating the whole property known municipally as 55 King Street as a property being of both Architectural and Historical Value pursuant to Section 29 of the Ontario Heritage Act, R.S.O. 1980.

AND WHEREAS the Council of the Corporation of the City of Trenton have deemed certain parts of the building located on the subject property as not significant for the restoration of the said building;

AND WHEREAS the certain parts of the said building have deteriorated to the extent that they pose a threat to public safety;

AND WHEREAS the Council of the Corporation of the City of Trenton being the owner of the lands and premises known as the Old Market Building and Town Hall, 55 King Street has caused notice of intention to repeal the designation of certain parts of the said property to the Ontario Heritage Foundation and has caused such a notice of intention to be published in The Trentonian, a newspaper having general circulation in the municipality;

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF TRENTON ENACTS AS FOLLOWS:

1. That the designation of the portions of the real property described in Schedule "A" to this By-Law be repealed.
2. The Municipal Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The Clerk is hereby authorized to cause a copy of this By-Law to be served on the Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality.

SCHEDULE "A"

The following parts of the real property known as the Old Market Square and Town Hall, 55 King Street, being Lots 14, 15, 16 and Part of Lot 17, Registered Plan 76, City of Trenton, are those parts subject to By-Law 89-1101.

1. The porches extending from the north and west faces of the Old Market and Town Hall Building.
2. The northeast corner addition of "Meyers House stone" and the north corner addition of angel stone.
