## NOTICE OF THE PASSING OF A BY-LAW TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the City of Trenton has passed By-Law No. 89-1196 on the 5th day of September, 1989, to designate a portion of a property known as Mount Pelion located at the North End of Dufferin Avenue, as being of historical value under the provisions of Section 29 of the Ontario Heritage Act, R.S.O. 1980.

BY -LAW NO. 89-1196

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN AS MOUNT PELION PARK (NORTH END OF DUFFERIN AVENUE) AS BEING OF HISTORICAL VALUE

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, as amended, authorizes the Council of a municipality to enact by-laws to designate real property to be of historic value;

AND WHEREAS the Council of the Corporation of the City of Trenton, being the owner of the lands and premises known as Mount Pelion Park, (North end of Dufferin Avenue), has caused Notice of Intention to Designate part of the aforesaid real property to be served on the Ontario Heritage Foundation, and has caused such Notice of Intention to be published once a week for two consecutive weeks in the Trentonian, a newspaper having general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF TRENTON ENACTS AS FOLLOWS:


- 1. The part of the real property defined by and measured from the contour line 130 metres above sea level to the top of the mountain, being known as Mount Pelion (North end of Dufferin Avenue), and more particularly shown in dark shading in Schedule "A" attached hereto, is hereby designated as being of historic value.
- 2. Notwithstanding Section 1 of this by-law, the installation, repair, maintenance, alteration and replacement of any public services located on the subject property, including water lines, storm sewers, telephone lines, roads or any other utilities, will not be affected by this designation.
- 3. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "B" attached hereto in the proper land registry office.
- 4. The Clerk is hereby authorized to cause a copy of this By-Law to be served on The Ontario Heritage Foundation, and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality, once a week for two consecutive weeks.

READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS FIFTH DAY OF SEPTEMBER, A.D., 1989.

is recognized as being of historic value for the following reasons:

Mount Pelion, also known as Mount Ossa, is considered by many as the most significant landmark in Trenton. The history of the mountain is composed of many old legends that have survived in Trenton for many years.

Legend says a cannon located at the top of the mountain came from a British warship that was sailing Lake Ontario during the war of 1812.

The old legend states that Samuel de Champlain climbed Mount Pelion for a better view of the countryside. Champlain was among the first explorers to map the Trent River and is the famous Founder of Quebec.

The scenic value of Mount Pelion is significant to the City of Trenton. From the peak, the view stretches well into the Murray Hills, with Belleville's skyline to the East. To the South, an observer can see Prince Edward County and the Bay of Quinte. Such a significant viewpoint is not only a central point of the City but a centre of the region.
