TAKE NOTICE that the Council of the Corporation of the Town of Renfrew has passed the following by-laws to designate the following properties as being of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337:

- (a) By-Law Number 51-82 designating the lands and buildings known municipally as the Chown Block, 301 Raglan Street South. (copy attached)
- (b) By-Law Number 52-82 designating the lands and buildings known municipally as the Fraser House, 154 Quarry Avenue. (copy attached)
- (c) By-Law Number 53-82 designating the lands and buildings known municipally as the Handford Block, 223 Raglan Street South. (copy attached).

# CORPORATION OF THE TOWN OF RENFREW

### BY-LAW NO. 52-82

A By-Law to designate the property known municipally as 154 Quarry Avenue as being of architectural and historical value or interest. (Fraser House)

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Councils of municipalities to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural and/or historical value or interest; and

WHEREAS the Council of the Corporation of the Town of Renfrew has caused to be served on the owners of the lands and premises known as the Fraser House at 154 Quarry Avenue and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

 $\underline{W\ H\ E\ R\ E\ A\ S}$  no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:

- 1) There is designated as being of architectural and historical value or interest the real property known as 154 Quarry Avenue more particularly described in Schedule "A" hereto.
- 2) The Municipal Solicitor is hereby directed to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the Land Registry Office.
- 3) The Clerk is hereby directed to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

4) That every person who contravenes any of the provisions of this By-Law or of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, as amended, or regulations thereunder, is guilty of an offence and on summary conviction is liable to a fine not to exceed the maximum penalty established by said Act and amendments thereto.

ADDENDUM TO BY-LAW NO. 52-82 OF THE TOWN OF RENFREW

REASONS FOR DESIGNATION OF PROPERTY KNOWN MUNICIPALLY AS 154 QUARRY AVENUE AND MORE PARTICULARLY DESCRIBED IN SCHEDULE "A" TO BY-LAW NO. 52-82:

"The Fraser House at Quarry Avenue and Barr Street is worthy of both historical and architectural significance. The house, probably designed by a noted Ottawa architect Werner E. Noffke, was built by M.J. O'Brien circa 1913. Circa 1930 it was sold to Alex Fraser, a Renfrew merchant. Currently, the Fraser family continues to own the house. The building itself has an unusual appearance which is emphasized by the existing colour scheme. Accordingly, the lively and dramatic exterior and interior features should be preserved for the enjoyment of future generations. Most windows of the house are deeply set containing patterned or stained glass panes, the most unusual of which is facing Quarry Avenue from the livingroom. Other features such as the entranceway, two different two storey porches, the panelled frieze, the rafters, brackets, dormers and a rare poured concrete capped chimney all contribute to the uniqueness of this house. Further unusual interior features include the twotiered panelling in the vestibule and hallway, a detailed livingroom mantelpiece, a diningroom mantelpiece, moulded baseboards and also pilasters with capitals and plinths between the living and dining room. In the apartments, the mantelpieces and two curved attic doors are also worthy of preservation. Finally, Alex Fraser designed and constructed a newel post and stair details and a cupboard built into a wall."
