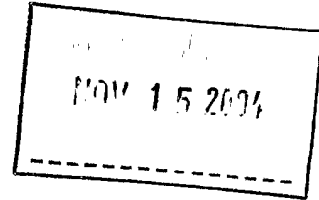



THE CORPORATION OF THE TOWNSHIP OF RIDEAU LAKES

BY-LAW NUMBER 2004-166

BEING a By-Law to Designate property (site) as a Cultural Heritage property as described herein.

WHEREAS the Ontario Heritage Act, R.S.O., 1990, Chapter O.18, Part 4, Section 29, authorizes Council to enact a By-Law to designate property (site) including structures thereon to be of a Cultural Heritage, value or interest;

AND WHEREAS Council has caused to be served upon the owner of the lands and premises known as a one acre plot of land presently containing a stone monument with a granite cross, being part of Lot Eighteen (18), Concession Five (5) of the said geographic Township of North Crosby, now the Township of Rideau Lakes;

COMMENCING West of an iron bar marking the East half of Lot Eighteen (18) North of the Parish Road allowance, north 42 degrees, 12 minutes East;

THENCE running Westerly along Parish Road allowance for two hundred (200) feet to an iron bar marking the Westerly limit;

THENCE North at an angle of 90 degrees to the road allowance for Parish Road, for two hundred (200) feet, being 200' by 200';


AND WHEREAS the reasons for designating the property (site) are as follows: The said site was originally the site of a log Church being the First Roman Catholic Church in the former Township of North Crosby, now the Township of Rideau Lakes. The site has cultural heritage value and an interest and relationship to the community. The granite Cross and Historical Plaque marking the site of the First St. Edward's Church, "The Mission on the Mountain" was erected in 1940 and reads "Site of the First Catholic Church in Crosby, 1840-1940"


AND WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Township of Rideau Lakes enacts as follows:


1. The property (site) as described herein be designated as a Cultural Heritage Site
2. Cause a copy of this By-Law to be registered against the property affected in the Land Registry Office; and
3. Cause a copy of this By-Law to be served on the owner of the property and to the Ontario Heritage Foundation; and
4. Publish in a newspaper having general circulation R.S.O. 1990, c.018, S.29 (3)


