BY-LAW NO. 6242-09

BEING A BY-LAW TO DESIGNATE GEORGE T. SOUTHWELL HOUSE, THE STRUCTURE MUNICIPALLY KNOWN AS 1001 GREEN STREET, AS BEING OF CULTURAL HERITAGE VALUE AND INTEREST

WHEREAS, in accordance with the provisions of Section 29 of the Ontario Heritage Act, R.S.O. 1990, c. 0.18, as amended 2005, the Council of the Corporation of the Town of Whitby considers it desirable to designate the exterior of the building on the property hereinafter described to be of cultural heritage value and interest;

AND WHEREAS, the Council of the said Corporation has caused to be served on the owners of the property municipally known as 1001 Green Street, Whitby, Ontario, and upon the Ontario Heritage Trust, notice of its intention to designate the structure at the aforesaid address to be of cultural heritage value and interest and has caused such notice to be published in a newspaper having general circulation in the Town of Whitby;

AND WHEREAS, no person has served a notice of objection to the proposed designation on the Clerk of the said Corporation;

NOW THEREFORE, the Council of the Corporation of the Town of Whitby enacts as follows:

 The structure located on the property municipally known as 1001 Green Street, Whitby, Ontario and more particularly described on Schedule "A" attached to and forming part of this by-law is designated as being of cultural heritage value and interest for the reasons set out in Schedule "B", attached hereto. 2. This designation shall not preclude any changes that may be deemed necessary for the efficient use of the structure provided that any changes shall be in keeping with the original and current character of the structure and shall be carried out in consultation with LACAC Heritage Whitby of the Town of Whitby.

DESCRIPTION OF PROPERTY – 1001 GREEN STREET

The George T. Southwell House is a two storey residential building, located on the south west corner of St. Peter Street and Green Street in the Town of Whitby.

STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

1001 Green Street was built in 1870 by Thomas Deverell (1828-1910) for George T. Southwell (1839-1892). George T. Southwell was born, probably in England, on June 11, 1839. He came to Whitby before 1867 and was connected with William Westlake in the building and contracting business for years. He was one of the most skilled curlers in Whitby and a noted member of the Oddfellows Lodge. In 1867 Mr. Southwell married Mary Ann Hastings and had a family of 14 children. Twelve of his fourteen children were born at 1001 Green Street and one child, Edith, lived to be 101 years old. George Southwell died at age 52. Oddfellows from several neighbouring towns, headed by the Whitby Brass Band, attended his funeral.

DESCRIPTION OF HERITAGE ATTRIBUTES

1001 Green Street possesses several features of the classic Ontario Gothic Revival and has been maintained in generally good condition. This style of domestic architecture was often described as vernacular and is indicative of the strong influence of Ontario's "Cottage Style." The plan of the two storey farm house is symmetrical with a crossgabled roof. The front façade features a raised veranda and a small Gothic style window in the gable over the entrance. The veranda is capped with a centre gable dormer which emphasizes the west elevation. Craftsmanship is emphasized in the steeply pitched roofs and ornamental bargeboard trim along the rakes of the centre gable. All of the windows (with the exception of two) are the original 6/6 double hung sashes and window frames.
