

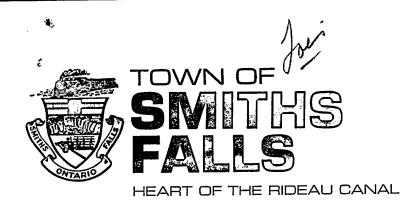

NOTICE OF PASSING OF BY-LAW NO. 5114-86

TAKE NOTICE that the Municipal Council of the Corporation of the Town of Smiths Falls has passed By-law 5114-80 to designate the property known municipally as 20 Beckwith Street, North as being of architectural and historical value or interest under Section 29 of The Ontario Heritage Act, Chapter 337, R.S.O. 1980.

The property is composed of part of Lot 225 and part of Lot 226, on the north side of William Street, as shown on plan 13884 and is known municipally as 20 Eeckwith Street, North.

The building is recommended for designation as being 1901 architectural interest, Erected in four story, flat roofed, brick structure, features repeating round arched windows on the second floor, four oriel windows on the third floor, south facade, four terraced windows with iron balustrades on the fourth floor south facade. It also features bracketed cornice, with prominent decorative, dentils and elaborately sculputed freize. The building is a fine example of turn of the century commercial architecture and the purpose of designation is to the Beckwith Street and William Street preserve facades.

THE CORPORATION OF THE TOWN OF SMITHS FALLS BY-LAW NO. 5114-86

A By-law to designate the property known municipally as $\\ \text{Twenty Beckwith Street, North as being of architectural and historical } \\ \text{value or interest.}$

WHEREAS the Ontario Heritage Act, Chapter 337, Section 29, R.S.O. 1980, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural and historic value or interest; and

WHEREAS the Council of the Corporation of the Town of Smiths
Falls has caused to be served on the owners of the lands and premises
known as Twenty Beckwith Street, North and upon the Ontario Heritage
Foundation, notice of intention to so designate the aforesaid real property
and has caused such notice of intention to be published in the same
newspaper having general circulation in the municipality once for each
of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk-Administrator of the municipality; and

WHEREAS the Council's reasons for the designation are as set \sim out in Schedule "B" attached hereto;

NOW THEREFORE the Council of the Corporation of the Town of Smiths Falls enacts as follows:

- 1. There is designated as being of architectural and historical value or interest the real property and exterior of the porperty known municipally as Twenty Beckwith street, North and as more particularly described in Schedule "A" attached hereto.
- 2. The Clerk-Administrator is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.

- 3. The Clerk-Administrator is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
- 4. That the provisions of this by-law shall come into force and take effect on the passing thereof.

ALL AND SINGULAR those certain parcels or tracts of lands and premises situate, lying and being in the Town of Smiths Falls, County of Lanark and Frontine of Ontario, and being composed of:

FIRSTLY:

The Fourth Halves of Lots Number 225 & 226, on the North side of William Street, in the said Town of Smiths Falls, according to Plan Number 13884 for the said Town of Smiths Falls.

SECONDLY:

Farts of Lots 225 & 226 on the North side of William Street, according to Plan Number 13884, which parts of land may be more particularly described as follows:

COMMENCING at a point in the East limit of said Lot Number 225, marking the Northerly limit of the lands more particularly described as Firstly herein, which point is 60 feet measured Northerly along the Easterly limit from the SouthEast angle of said Lot Number 225;

THENCE Northerly along said Easterly limit of Lot Number 225, 18 feet to

SCHEDULE "B" to BY-LAW NO. 5114-86 REASONS FOR DESIGNATION

Heritage Designation Twenty Beckwith Street, North

The building at 20 Beckwith Street, North, is recommended for designation as being of architectural interest. Erected in 1901 this four story, flat roofed, brick structure, features repeating round arched windows on the second floor, four oriel windows on the third floor, south facade, and four terraced windows with iron balustrades on the fourth floor south facade. It also features a decorative, bracketed cornice, with prominent dentils and elaborately sculptured freize.

The building is a fine example of turn of the century commercial architecture and the purpose of designation is to preserve the Beckwith Street and William Street facades.
