In the matter of the Ontario Heritage Act R.S.O. 1990 Chapter O.18 and the property located at 299 Queen Street W, Hepworth, Plan 269 Pt Lot 100 RP3R3720 Part 1 RP3R6163 Part 1, Town of South Bruce Peninsula, County of Bruce, Province of Ontario.

### **Notice of Intention to De-Designate**

Take notice that the Council of the Corporation of the Town of South Bruce Peninsula intends to de-designate, under Part IV Section 31 of the Ontario Heritage Act, the property and appurtenances thereto located at the municipal address known as 299 Queen Street W, Hepworth.

**Reason for Proposed Repeal of the Designation By-Law** – By-Law 9-89 adopted on July 26, 1989 by the municipal Council for the Village of Hepworth does not contain significant details as to the attributes which are to be protected, the municipal address is incorrect, the designation process including registration of the by-law on title and serving the Ontario Heritage Trust were not completed and the owner no longer wishes for there to be a heritage designation on their property.

Notice of any objection to the proposed designation may be served on the Town Clerk at the address below within thirty days of the 4th of September, 2014. The notice must set out the reason(s) for the objection, and all relevant facts.
