


TAKE NOTICE That the Council of the Corporation of the Township of South Frontenac intends to designate property, including lands and buildings, known municipally as 4979 Road 38, St. Paul's United Church, as a property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, R. S. O. 1990, Chapter O.18, as amended.

Reasons for the Proposed Designation

The subject of designation is the exterior walls, steps and tower of the 1919 structure. The current structure replaces the Wesleyan Methodist Church, the first church to be established in the village of Harrowsmith in 1849, nine years after the founding of the village itself. The Church has played a significant role in the wider community for over 150 years. St. Paul's is the most visible stone building on the village's main thoroughfare. The exterior walls and tower are constructed in a "checkerboard" pattern of light and dark "rock-cut" limestone from two local quarries. The stone was cut and hauled by local families, who were also involved in the building of the structure.

Notice of objection to the proposed designation, together with a statement of all relevant facts may be served on the Clerk of the Township of South Frontenac before the 11th day of August, 2000.
