CORPORATION OF THE VILLAGE OF VICTORIA HARBOUR

BY-LAW NO. 97-1982

A By-law to repeal in part the operation of By-Law 87-1982 designating certain lands to be of architectural and historical value.

WHEREAS Section 29 of the Ontario Heritage Act authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS pursuant to the said Section 29, the Council of the Corporation of the Village of Victoria Harbour passed. By-Law 87-1982 on the 11th day of January, 1982 to designate certain lands and premises as described in Schedule "A" thereto to be of architectural and historical value; and

WHEREAS the Council of the Corporation of the Village of Victoria Harbour has deemed it desirable to repeal the said By-Law 87-1982 insofar as it affects a portion of the lands described in By-Law 87-1982 for the reason that these lands are not of architectural or historical value; and

_WHEREAS the Council of the Corporation of the Village of Victoria Harbour has caused to be served on the owners of the lands and premises known as The Harbour Hardware at William and Albert Streets, and upon the Ontario Heritage Foundation, notice of intention to so repeal By-Law 87-1982 in respect to certain lands and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed repeal has been served on the Clerk of the municipality;

NOW THEREFORE the Municipal Council of the Corporation of the Village of Victoria Harbour enacts as follows:

- 1. The designation of being of architectural and historical value or interest in respect to the lands described in Schedule "A" attached hereto is revoked.
- 2. By-Law 87-1982 of the Corporation of the Village of Victoria Harbour, insofar as it affects the lands described in Schedule "A" attached hereto is hereby repealed.
- 3. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" attached hereto in the proper Land Registry Office.
- 4. The Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

BY-LAW READ A FIRST, SECOND AND THIRD TIME and passed in open Council this 16th., day of August, 1982.
