رم صروف المساسر الد TOWN OF PORT HOPE BY-LAW NUMBER 3120/78 A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS ST. MARK'S CHURCH, 53 KING STREET, PORT HOPE AS BEING OF HISTORIC VALUE OR INTEREST. WHEREAS Section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest; AND WHEREAS Council of the Corporation of the Town of Port Hope has caused to be served on the owner of the lands and premises known as St. Mark's Church, 53 King Street and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; AND WHEREAS the building is a priceless connection with early history and settlers of Port Hope, resulting in an important tourist attraction to this area. The Royal Family used this local Church as a place of worship and left an autographed book that is on permanent display. Canada's first native Governor-General, Vincent Massey and his family are buried in the adjacent cemetery. The building is one of the oldest church buildings in continuous use in the Province of Ontario; AND WHEREAS no notification of objection to the proposed designation has been served on the Clerk of the municipality; NOW THEREFORE the Council of the Corporation of the Town of Port Hope enacts as follows: 1. There is designated as being of historical value or interest the frame building known as St. Mark's Church and the Parish Hall attached thereto and the real property appurtenant thereto being more particularly described as ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Port Hope, in the County of Northumberland (formerly County of Durham) being part of Town Plot Lots 6, 7 and 8, Stewart Plan and being more particularly designated as Part 1 on a Plan received and deposited on November 22nd, 1977 as Plan 9R-933 for the Registry Division of Port Hope (No. 9). 2. The Clerk-Administrator and the solicitor for the Town of Port Hope

are hereby authorized to serve, publish and register copies of the By-Law in accordance with <a href="https://example.com/heritage-Act, 1974">The Ontario Heritage Act, 1974</a>.

READ a FIRST, SECOND and THIRD time and finally passed in Open Council this 6th. day of February , 1978.

## REASON FOR HISTORICAL DESIGNATION

TOWN OF PORT HOPE
