NOTICE OF PASSING OF BY-LAW

TAKE NOTICE that the Council of the Corporation of the Town of Port Hope has passed by-law number 3164/78 to designate the following property as being of architectural value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122:

- (a) 284 Ridout Street, Port Hope, Ontario.
- (h) Reason for Proposed Designation

 Built between 1850 and 1853, Forge Cottage is an example of
 the many variations of the Georgian Cottage. It is remarkable for its sidelights and transom light, its brick
 pilasters with recessed panels and its small fanlight
 window above the door. The door-case, with its symmetrical
 pilaster trim surmounted by wooden capitals, much-divided
 sidelights and transom light, is characteristic of the
 mid-nineteenth century, circa 1840 1855.

TOWN OF PORT HOPE

BY-LAW NUMBER 3164/78

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 284 RIDOUT STREET, PORT HOPE AS BEING OF ARCHITECTURAL VALUE OR INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS Council of the Corporation of the Town of Port Hope has caused to be served on the owner of the lands and premises known municipally as 284 Ridout Street and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS the building was built between 1850 and 1853 and is an example of the many variations of the Georgian Cottage. It is remarkable for its sidelights and transom light, its brick pilasters with recessed panels and its small fanlight window above the door. The door-case, with its symmetrical pilaster trim surmounted by wooden capitals, much-divided sidelights and transom light, is characteristic of the mid-nineteenth century, circa 1840-1855.

AND WHEREAS no notification of objection to the proposed designation has been served on the Clerk of the municipality;

NOW THEREFORE the Council of the Corporation of the Town of Port Hope enacts as follows:

- There is designated as being of architectural value or interest the building municipally known as 284 Ridout Street and the real property appurtenant thereto being more particularly described as ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Port Hope, in the County of Northumberland (formerly County of Durham) being Lot 12 on the north side of Ridout Street according to the Ridout Plan being Plan Number 1 for the Town of Port Hope.
- The Clerk and the solicitor for the Town of Port Hope are hereby authorized to serve, publish and register copies of the By-Law in accordance with <u>The Ontario</u> Heritage Act, 1974.

READ a FIRST, SECOND and THIRD time and finally passed in Open Council this 6th day of November, 1978.
