TAKE NOTICE that the Municipal Council of The Corporation of the Municipality of Port Hope intends to designate the building, including the lands surrounding the building, at the following municipal address as a property of architectural and/or historical value or interest, pursuant to the provisions of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, Part IV.

1. 30 Bruton Street

Reasons for the Proposed Designation

Incorporating elements from an earlier house this Victorian house, is on a stone foundation, L-shaped with three gables. An elegant front verandah shelters a storm porch with oversized finely detailed doors dating from the 1850s. Other important features include wooden windows with original shutters, three ornately carved stone lintels and, on the western elevation, a deep bay and narrow verandah. Interior features, include mouldings from the 1850s and 1880s, pine and maple board flooring, and a Rumford fireplace with an ornate marble chimney piece.

2. 187 Walton Street

Reasons for the Proposed Designation

The Albion, later renamed The Temperance Hotel, was built in 1857 on the site of a former coaching inn. Two and a half storeys on a high cut-limestone foundation, the exterior is symmetrical, side-gabled with parapet walls. Clad in triple brick, the façade is Flemish bond, the other elevations common bond. Important features include the front entrance, the six over six wooden windows, the corbelled cornice and the pilasters topped with the date, 1857.
