# CORPORATION OF THE TOWN OF PORT HOPE BY-LAW NO. 22/94

A BY-LAW TO DESIGNATE CERTAIN PROPERTY IN THE TOWN OF PORT HOPE AS BEING OF HISTORIC VALUE OR INTEREST.

WHEREAS the Ontario Heritage Act, R.S.O. 1990 authorizes the Council of the municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest:

AND WHEREAS the Council of the Corporation of the Town of Port Hope deems it desirable to designate the following property:

1. Col. Arthur T.H. Williams monument

and has caused to be served on the owners of the respective land and premise, and upon the Ontario Heritage Foundation, Notice of Intention to designate the aforesaid real property and has caused such Notice of Intention to be published in a newspaper having a general circulation in the municipality once a week for each of three consecutive weeks, namely the "Port Hope Evening Guide";

AND WHEREAS the land of the subject property is more particularly described in Schedule "A-1" attached hereto and the reasons for designating the respective property are set out in Schedule "B-1" attached hereto;

AND WHEREAS no notification of objections to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PORT HOPE ENACTS AS FOLLOWS:

- There is designated as being of historic and/or architectural value or interest the following real property as an important component of the Town of Port Hope:
  - (1) "Colonel Arthur T.H. Williams monument" being more particularly described in Schedule "A-1" attached hereto and forming part of this By-law. The reasons for the designation of this property are set out in Schedule "B-1" attached hereto and forming part of this By-law.
- The Clerk and the Solicitor of the Town of Port Hope are hereby authorized to serve, publish and register copies of the By-law in accordance with the Ontario Heritage Act, R.S.O. 1990.

READ a FIRST and SECOND time this 27th day of June, 1994.

LEGAL DESCRIPTION:

### Col. Arthur T.H. Williams Monument

Part 13, Plan 39R-6747, in the Town of Port Hope, in the County of the Northumberland, in the Province of Ontario. Part of the Market Square, Smith Estate Plan.

The historic Col. Arthur T.H. Williams monument located on the property at the front of the Town Hall building.

OWNER: Town of Port Hope, Ontario, Canada LOCATION: Port Hope Town Hall, east front lawn

To Commemorate

The Devoted Patriotism and Heroic Bravery of Lieutenant Colonel Arthur T.H. Williams, M.P. Commanding The Midland Battalion of Volunteer Militia who after gallantly leading the victorious and decisive charge at the Battle of Batoche, during the rebellion in the North-west Territories
Died of sickness contracted in the discharge of his duty, rear Fort Pitt, N.W.T. on the 4th July 1885.

This monument is erected in his native Town by his admiring countrymen throughout Canada assisted by his companions in arms, and the Government of the Dominion.
