



NOTICE OF PASSING OF BY-LAW

TAKE NOTICE that the Council of the Corporation of the Town of Campbellford has passed By-law 1991-15 to designate the following property as being of architectural and historical value or interest under Part IV of The Ontario Heritage Act (RSO 1980, ch. 337)

17 SECOND STREET

REASONS FOR THE DESIGNATION OF 17 SECOND STREET

The house was built in 1874 by the Dunwoodie Brothers and is constructed of red clay brick with buff brick lintels and quoins.

The front facade has two projecting bays with the windows made of 2 panes vertical hung sash with arched tops. The bay projections have a 6 inch wood cornice.

The central doorway has 2 side lights and a curved top consisting of an 8 light transom. The narrow side panels each have 2 panes.

Second storey windows are lancet shaped casement windows with 3 small lancet panes above a vertically divided base.

The roof has a central dormer and a king post rising out of the centre.

The windows in the side walls consist of 2 upper and 2 lower windows, each being a vertical hung sash with 2 panes.

The rear brick extension appears to be original in the main building.

BY-LAW 1991-15

being a by-law to designate the property known municipally
as 17 Second Street
as being of architectural and historical value or interest

WHEREAS Section 29 of the Ontario Heritage Act (R.S.O. 1980, ch. 337),
as amended, authorizes the council of a municipality to enact by-laws
to designate a real property, including all buildings and structures
thereon, to be of architectural or historical value or interest;

AND WHEREAS the Council of the Corporation of the Town of Campbellford
has caused to be served on the owners of the lands and premises known
as 17 Second Street and upon the Ontario Heritage Foundation, notice of
intention to designate the said property and has caused notice of intention
to be published in the Campbellford Herald, the first publication being
February 26, 1991;


AND WHEREAS no notice of objection to the proposed designation has been
served on the Clerk;

NOW THEREFORE the Municipal Council of the Corporation of the Town of
Campbellford hereby enacts as follows:

1. There is designated as being of architectural and historical value
or interest the property known municipally as 17 Second Street
and more particularly described as all of Lot 2 and Part of Lot
6, South of Second Street and West of Front Street, Block XXXVI,
Plan 112.
2. The Municipal Solicitor is hereby authorized to cause a copy of
this by-law together with the reasons for designation attached
hereto as Schedule "A" to be registered against the property
described above in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this by-law
to be served on the owner of the aforesaid property and on the
Ontario Heritage Foundation and to cause notice of the passing
of this by-law to be published in a newspaper having general
circulation in the Municipality.

The roof has a central dormer and a king post rising out of the centre.

The rear brick extension appears to be original in the main building.
